Tentative April Public Meeting Schedule

**APRIL PUBLIC MEETINGS**

PPWG discussed the feasibility of going to the Chigniks. Transportation cost for the team would be \$2,800. Marty stated that they did receive oiling; however, subsistence was not affected. Peg asked if it would be cheaper for one person to go. LJ stated "no" because it is a charter. Sandy suggested exploring government aircraft in terms of cost. The downside is everyone will know you flew in government aircraft, which could be interpreted as not spreading money around to private enterprise. Ken stated the question is are we well served in spending this amount of money for communities at the very edge of the spill. What do they benefit and what do we benefit should also be asked. Sandy stated he doesn't feel the amount is unreasonable compared to some of the other expenditures. LJ stated it would be \$2800 if the team stayed overnight and \$2200 if they didn't. She got figures on charters coming out of Akhiok or Anchorage.

Dave was asked to join the meeting to provide input on the feasibility of scheduling meetings in the Chigniks. He stated the map he has seen does not show Chignik as oiled. Sandy pointed out that we made the invitation already. Marty requested that Sandy get figures on the feasibility of using government aircraft. Sandy stated the cost would include the aircraft and pilot's per diem. Marty will forward this information to the RT for a decision on whether they want to hold meetings in the Chigniks.

**TEAMS**

The RT agreed to two teams with the following four RT members participating: Marty, Ken, Dave and Mark. Each team would include staff support, a PPWG member and an RT member. Marty stated Dave

approved Barbara and LJ as support staff. Sandy will work with RPWG to nail down which meeting they will attend. Marty would like to keep RPWG participants to a maximum of four people; however, two would be fine. Sandy suggested the best combination would be to have a state and federal representative on each team. Ken agreed but stated that might not always be possible. Sandy stated the only RPWG member not available is Carol.

#### **NEXT MEETING**

The next PPWG meeting is scheduled for Friday, March 26, at 8:30. Peg stated she will be gone for the next two weeks and will have to turn some of the school scheduling over to someone else. Marty asked LJ what her schedule looks like. LJ stated she is only worried about distributing the brochures. Ron stated the mailing consists of three tiers including p.o. boxes, newspaper inserts, and general mailings. Peg volunteered to come to Anchorage on the 5th for the intense mailing. Marty stated she should go ahead and schedule that.

#### **SCHOOL PRESENTATIONS**

Ken asked what is the status of the school presentations. Peg has contacted Kodiak and Cordova because she had contact names and also the timing would facilitate a presentation. LJ stated KMXT has agreed to broadcast the meeting in Kodiak.

#### **GRAPHICS**

Ken asked if there will be graphic blowups. Sandy stated that he had made a request to Bob to have the graphic artist develop something; however, he has not received a response. It is very possible to have graphic products blown up. Marty requested that Ken discuss graphics with Bob. Marty suggested letting people develop their own percentages on a large blowup during the meetings. Handouts and wall charts will be discussed at the next PPWG meeting.

#### **SCRIPT**

Marty asked when the script will be started. Sandy stated that the first draft was to be prepared by Bob, but Sandy will assist since he is not going on vacation. Bob is currently busy with the brochure; however, either Bob or Sandy can start on the task

tomorrow. The second version of the script would go to the RT on March 29th.

#### **BROCHURE**

Ken stated that the brochure is close to being final. The schedule indicated that the brochure was to go to the layout person on March 17; however, it is still being revised. The meeting schedule is such that time for a delay was built in.

#### **PARAMETRIX CONTRACT**

Peg expressed concern that the Parametrix contract has a component to do annual reports on restoration progress and circulate them to the user groups. Ken stated they are developing the conceptual monitoring plan but will not be doing the implementation for the monitoring. Sandy stated they do have a contract and John could provide Peg a copy if she wanted to review it. Marty stated she will review the contract and discuss it with the RT. Peg felt that PPWG should be a part of any public participation discussions with Parametrix. Sandy suggested discussing this contract with John for more information prior to discussing it with the RT.

#### **MISCELLANEOUS**

LJ suggested taking a gift to the villages and stated that Ernie suggested taking a box of fruit to each village.

Marty stated that everything seems to be falling into place, and she feels really good about the schedule.
