1. Applicant

The Liberty Island oil and gas development and production project will develop oil and natural gas reserves beneath Foggy Island Bay in the Alaskan Beaufort Sea at 70°16' 45" north latitude, 147°33' 29" west longitude. BP Exploration (Alaska), Inc. (BPXA) plans to construct an artificial gravel island between the McClure Islands and the coast in water depths of about 22 feet (ft) on federal OCS oil and gas lease OCS-Y-1650 (Sale 144) in Foggy Island Bay. The facility will support field development drilling and hydrocarbon extraction. A sub-seabed pipeline will bring sales-quality oil onshore to connect with the Badami Pipeline. A detailed project

description is provided in the fact sheet explaining this draft NPDES permit and the Environmental Impact Statement for the Liberty Development and Production Project.

2. <u>Tentative NPDES Permitting Determination</u>

The Region 10 Office of EPA has determined to issue an NPDES wastewater discharge permit to the applicant. NPDES permits impose limits on the pollutants and require best management practices as well as monitoring of the wastewater effluents. A fact sheet is available for the proposed NPDES permit.

3. Public Comments

Persons wishing to comment on the tentative determinations contained in the proposed permit may do so in writing within 60 days of the date of this public notice. Comments must be received within this 60-day period to be considered in the formulation of final determinations regarding the application. All comments should include the name, address and telephone number of the commenter and a concise statement of the exact basis of any comment and the relevant facts upon which it is based. All written comments and requests should be submitted to EPA at the above address to the attention of Burney Hill, Aquatic Environmental Scientist.
